

TERMS AND CONDITIONS OF THE VIDEO COMPETITION “Savior Street Food Contest”

1. Term of the competition:

The application for participation in the online video competition “Savior Street Food Contest” hereinafter called the Competition is by producing a video and uploading it to the website www.GIILife.com, hereinafter called [GIILife](http://www.GIILife.com) for brevity. The application will run from 00:00 (+2GMT) on 17.05.2018 until 24:00 (+2GMT) on 01.08.2018. After the referred date in this Article (01.08.2018) no further entries will be permitted. The voting will start at 12:00 (+2GMT) on 02.08.2018 and ends on 15.08.2018 at 24:00 (+2GMT). The voting will be through the system of likes from registered users of the website [GIILife](http://www.GIILife.com). The number of likes will not be visible until 10.08.2018 at 12:00 (+2GMT).

2. Name of the contest - “Savior Street Food Contest”.

3. Organizers of the contest: “Savo’s Productions” Ltd. with headquarters 130 Kniaz Boris I Str., 1000, Sofia, Bulgaria.

4. The competition consists of producing a short video of preparing traditional street food from the territory of Egypt; uploading the video of the Participant which is their own work and they own the copyright for it. With submitting the video for the Contest, the Participant agrees to grand the copyrights of it to the Organizer. For more information as to whether you qualify as a Participant refer to Part 6.

5. The competition will end with an evaluation of the videos through the system of votes on the [GIILife](http://www.GIILife.com) in the form of likes.

6. Participants in the competition:

6.1. Participants in the competition can be people from ages, above 18 years old.

6.2. Participants in the competition can be only natural persons who are or have registered in the [GIILife](http://www.GIILife.com) website within the term of the competition.

6.3. Employees of “Savo’s Productions” Ltd., their relatives and their families are not allowed to participate in the competition.

6.4. Territory: The competition is held online. Participants are welcome to submit their entries from Egypt.

6.5.Prize: There will be only one prize in the Competition, which will be rewarded to the winning Participant is a brand new iPhone X.

7. Competition mechanisms:

7.1. In order to take part in the competition, each Participant has to register in the [GII Life](#) website.

7.2. After successfully registering the Participant will have to produce a short video above (less than 40 minutes) of how a typical street food meal or drink is being prepared in his/her country. The Participant should shoot and upload a video of their own in one of the Sections, depending on the country of origin of the video: “*Savior Street Food Contest – Pakistan*” OR “*Savior Street Food Contest – Egypt*” in the [GII Life](#) website and beneath the material to state his/her names and the names of the main participants in the video as well as the name of the meal or drink. The video material should be recorded especially for the Contest and should not have been shown in its entirety or parts of it before.

7.3. The Participants have to upload the copyrighted material, which is their own work before 24:00 (+2GMT) on 01.08.2018 in the [GII Life](#) website following the instructions on the website.

7.4. Each Participant, who complies with the conditions laid down by Part 1 to Part 6 from the Terms of the Competition will automatically become a Participant in the competition and qualifies for the award nomination complying with the terms in Part 1 to Part 6.

8. Determination of the promotional prize:

8.1. There will be only one Winner as laid down by Part 6.5. The winning Participant will be called the Winner for brevity hereinafter.

8.2. The Winner will be determined according to voting that consists of the number of likes their uploaded video has received in the GII network that complies with the terms and conditions. The Winner video will be the one that receives most likes in GII network until 15.08.2018 at 24:00 (+2GMT).

8.3. The award announcement will take place on 16.08.2018 and it will be preliminarily appointed and announced on the [GII Life](#) website.

9. Award of the prize:

9.1. The prize for the Winner consists of a brand new iPhone X.

9.2. The Winner will be contacted to provide the Organizers with an address where the award will be delivered within 1 week.

10. Additional provisions:

10.1. By uploading copyrighted material of their own in one of the sections, depending on the country of origin of the video: “*Savior Street Food Contest – Pakistan*” OR “*Savior Street Food Contest – Egypt*” in the website of the competition, each Participant accepts these General conditions and gives “Savo’s Productions” Ltd. voluntarily their personal details, which are necessary for the participation in the competition, as well as their agreement for these details to be stored and processed by the Organizers, and the copyrights of their materials, all in compliance with the provisions in the law of the personal data protection.

- c. The Winner agrees to be photographed, recorded and to participate in public events of the Organizer with advertising nature, without receiving additional rewards for that.
